A BILL FOR AN ACT

To amend State Law No. 11-72 to appropriate the \$685,000 Kosrae Community Health Center Program Grant (CHC) for the performance period ending May 31, 2017.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend State Law No. 11-72 to
2 fully appropriate the Kosrae CHC program funding from \$650,000 to \$685,000 for
3 the performance period ending May 31, 2017.

4 Section 2. Amendment. Kosrae State Law No. 11-72 is hereby amended at Title,
5 Section 1, and Section 2 to read as follows, respectively:

6 (1) To appropriate the sum of \$685,000 from the United States Grant Fund
7 of the Kosrae State Treasury to fund the operations and activities of the Kosrae
8 Community Health Center.

9 (2) Section 1. Appropriation. The sum of \$685,000 is hereby appropriated
10 from the United States Grant Fund of the Kosrae State Treasury for the purpose
11 of funding the operations and activities of the Kosrae Community Health Center.

12 (3) Section 2. Allottee and Lapse Date. All funds appropriated by this act
13 shall be allotted, managed, administered and accounted for in accordance with
14 applicable laws. The allottee of the funds appropriated shall be the Governor of
15 the State of Kosrae, who shall be responsible for ensuring that these funds, or so
16 much thereof as may be necessary, are used for the purpose for which are
17 appropriated and that no obligations are incurred in excess of the sum
18 appropriated. The authority of the allottee to obligate funds appropriated by this

1 act shall lapse on May 31, 2017. Such lapse date established by this act, however,
2 shall be extendable to an extended grant funding expiration date, as would
3 otherwise be provided by grant extension document(s) issued by the appropriate
4 grantor/agency.

5 Section 3. Effective Date. This act shall become law upon approval by the
6 Governor or upon its becoming law without such approval.
