

A BILL FOR AN ACT

To appropriate the sum of \$15,000 from the United States Grants Fund of the Kosrae State Treasury to fund the operations and activities of the FY17 Oral Health Program.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$15,000 is hereby appropriated form the
2 United States Grants Fund of the Kosrae State Treasury for the purpose of funding the
3 operations and activities of the FY17 Oral Health Program.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
5 allotted, managed, administered and accounted for in accordance with applicable laws.
6 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
7 shall be responsible for ensuring that these funds, or so much thereof as may be
8 necessary, are used for the purpose for which are appropriated and that no obligations
9 are incurred in excess of the sum appropriated. The authority of the allottee to obligate
10 funds appropriated by this act shall lapse on August 31, 2017.

11 Section 3. Effective Date. This act shall become law upon approval by the
12 Governor or upon its becoming law without such approval.
