**A BILL FOR AN ACT**

To appropriate the sum of \$200,000 from the Foreign Assistance Fund of the Kosrae State Treasury to fund the Project to Improve the Kosrae International Airport Terminal Arrival Lobby, Immigration and Customs Inspection Areas, Restrooms and Baggage Claim Areas; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$200,000 is hereby appropriated from the  
2           Foreign Assistance Fund of the Kosrae State Treasury to fund the Project to Improve the  
3           Kosrae International Airport Terminal Arrival Lobby, Immigration and Customs  
4           Inspection Areas, Restrooms and Baggage Claim Areas; and for other purposes.

5           Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be  
6           allotted. Managed, administered and accounted for in accordance with applicable laws.  
7           The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who  
8           shall be responsible for ensuring that these funds, or so much thereof as may necessary,  
9           are used for the purpose for which are appropriated and that no obligations are incurred  
10          in excess of the sum appropriated. The allottee shall also be responsible to ensure that  
11          applicable grant terms and conditions associated with the sum hereby appropriated are  
12          met.

13          Section 3. Effective Date. This act shall become law upon approval by the  
14          Governor or upon its becoming law without such approval.
