

A BILL FOR AN ACT

To appropriate the sum of \$100,000 from the Foreign Assistance Fund of the Kosrae State Treasury to fund the activities of the Kosrae Agriculture Program; and other activities of the State; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. This act is to appropriate the FSMNG funding of \$100,000
2 to fund or defray the costs of the fiscal year 2017 activities of the Agriculture
3 Development program; and to also fund other activities of the State; and for other
4 purposes.

5 Section 2. Appropriation. The sum of \$100,000 is hereby appropriated from the
6 Foreign Assistance Fund of the Kosrae State Treasury for the purposes stated per Section
7 1 of this act.

8 Section 3. Apportionment. The sum appropriated by Section 2 of this act is
9 hereby apportioned as follows:

10	(1)	Agriculture Development	83,378
11	(2)	Senior Citizens' Day	4,000
12	(3)	Liberation Day	8,000
13	(4)	KSG Wellness Program	1,622
14	(5)	Youth Day	1,000
15	(6)	Community Holiday (Memorials)	2,000

16 Section 4. Allottee and Lapse Date. All funds appropriated by this act shall be
17 allotted, managed, administered and accounted for in accordance with applicable laws.
18 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who


1 shall be responsible for ensuring that these funds, or so much thereof as may be
2 necessary, are used for the purposes for which are appropriated and that no obligations
3 are incurred in excess of the sum appropriated. The authority of the allottee to obligate
4 funds appropriated by this act shall lapse on 08/31/18.

5 Section 5. Effective Date. This act shall become law upon approval by the
6 Governor or upon its becoming law without such approval.
