A BILL FOR AN ACT

To appropriate the amount of \$2,301,074 from the Amended Compact Fund of the Kosrae State Treasury to fund FY2019 Infrastructure funded Projects in the State; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The amount of \$2,301,074 is hereby appropriated from
2 the Amended Compact Fund of the Kosrae State Treasury for the purpose of funding
3 FY2019 Compact Infrastructure funded projects.

4 Section 2. Appropriation. The amount appropriated herein shall be apportioned as
5 follows:

8 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be
9 allotted, managed, administered, and accounted for in accordance with applicable laws.
10 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
11 shall be responsible for ensuring that these funds, or so much thereof as may be necessary,
12 are used for the purpose for which are appropriated and that no obligations are incurred in
13 excess of the sum appropriated. The authority of the allottee to obligate funds
14 appropriated by this act on Section 2(1) shall lapse on September 30, 2022 and Section
15 2(2) shall lapse on September 30, 2020.
