BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. <u>Appropriation</u>. The amount of \$20,000 is hereby appropriated from the Revenue Fund of the Kosrae State Treasury for the purpose of providing the State's financial contribution to the PIDB for its continuous services to the region and the people.

 Section 2. Apportionment. The suppose of the latest and the people.
- Section 2. <u>Apportionment</u>. The sum appropriated herein shall be apportioned as follows:
- 6 1. Pacific Island Development Bank (PIDB) \$20,000
- Section 3. <u>Allotee and Lapse Date</u>. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with the applicable laws.
- 9 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
- shall be responsible for ensuring that these funds, or so much thereof as may be necessary,
- are used for the purpose for which are appropriated and that no obligations are incurred in
- 12 excess of the sum appropriated.
- Section 4. <u>Effective Date</u>. This act takes effect upon the approval of the Governor or upon its becoming law without such approval.

 - Section 3. Allotee and Lapse Date. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with the applicable laws. The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated and that no obligations are incurred in excess of the sum appropriated.
 - Section 4. <u>Effective Date</u>. This act takes effect upon the approval of the Governor or upon its becoming law without such approval.
