

A BILL FOR AN ACT

To appropriate the sum of \$50,000.00 from the Foreign Assistance Fund of the Kosrae State Treasury providing funding for the Kosrae Conservation & Safety Organization (KCSO) project; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$50,000.00 is hereby appropriated from the
2 Foreign Assistance Fund of the Kosrae State Treasury for the purpose of funding the
3 Kosrae Conservation & Safety Organization project.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
5 allotted, managed, administered, and accounted for in accordance with applicable laws.
6 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
7 shall be responsible for ensuring that these funds, or so much thereof as may be necessary,
8 are used for the purpose for which are appropriated and that no obligations are incurred in
9 excess of the sum appropriated.

10 Section 3. Effective Date. This act takes effect upon the approval of the Governor
11 or upon its becoming law without such approval.
