A BILL FOR AN ACT

To appropriate the sum of \$5,000 from the Revenue Fund of the Kosrae State Treasury to fund the 2019 International Women's Day recognition and celebrations by each community women association; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$5,000 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury to fund the 2019 International Women's Day
3 recognition and celebrations by each community women association.

4 Section 2. Apportionment. The sum appropriated herein shall be apportioned as
5 follows:

6	1. Lelu Women Association	\$1,500
7	2. Malem Women Association	\$1,000
8	3. Tafunsak Women Association	\$1,500
9	4. Utwe Women Association	\$1,000

10 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
11 administered, and accounted for in accordance with applicable laws. The allottee of the
12 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
13 for ensuring that these funds, or so much thereof as may be necessary, are used for the
14 purpose for which are appropriated and that no obligations are incurred in excess of the
15 sum appropriated.

1 Section 4. Effective Date. This act takes effect upon the approval of the Governor
2 or upon its becoming law without such approval.


