A BILL FOR AN ACT

To amend Title 14 of the Kosrae State Code at, Chapter 1, by inserting a new Section 14.109 to establish an exclusive industrial zone; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to amend Title 14 of the Kosrae  
2 State Code at Chapter 1, by inserting a new Section 14.109, to establish an exclusive  
3 economic and industrial zone. The areas to be included in said zone will be the Kosrae  
4 International Airport with the adjacent port and dock; a total land area of 109.26 acres,  
5 which is equivalent to 442,162.40 Square Meters.

6           Section 2. Amendment. Chapter 1 of Title 14 is amended by inserting a new  
7 Section 14.109 to read as follows:

8           “Section 14.109. Exclusive Industrial Zone.

9                   (1)   Kosrae International Airport and the port and dock adjacent to it  
10                   shall be an exclusive economic and industrial zone.

11                           (i)   The established zone is a total land area of 109.26 acres; an  
12                           equivalent of 442,162.40 square meters.

13                           (ii)   Activities and operations on, within, and relate to  
14                           established zone shall be legal and authorized by law; except  
15                           where provided otherwise in this section.

1 (iii) Activities and operations on, within, and relate to  
2 established zone shall be based on set and established  
3 schedule, including Sundays, by the respective management  
4 and administration.”

5 Section 3. Effective Date. This act takes effect upon the approval of the Governor  
6 or upon its becoming law without such approval.
