

A BILL FOR AN ACT

To appropriate the sum of \$735,200 from the United States Grants Fund of the Kosrae State Treasury, to fund the operations and activities of the Kosrae Community Health Center Program for budget period June 1, 2019 – May 31, 2020; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$735,200 is hereby appropriated from the
2 United States Grants Fund of the Kosrae State Treasury, for the purpose of funding the
3 operations and activities of the Kosrae Community Health Center for budget period June
4 1, 2019 – May 31, 2020.

5 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
6 allotted, managed, administered, and accounted for in accordance with applicable laws.
7 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
8 shall be responsible for ensuring that these funds, or so much thereof as may be necessary,
9 are used for the purpose for which are appropriated and that no obligations are incurred in
10 excess of the sum appropriated. The authority of the allottee to obligate funds appropriated
11 by this act shall lapse on May 31, 2020.

12 Section 3. Effective Date. This act takes effect upon the approval of the Governor
13 or upon its becoming law without such approval.




