A BILL FOR AN ACT

To appropriate the sum of \$100,000 from the Foreign Assistance Fund of the Kosrae State Treasury to provide supplemental budget for the operational budget for the current fiscal years 2019 and 2020, with State contributions to the Micronesian Legal Services Corporation (MLSC) and Pacific Island Development Bank (PIDB); and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. <u>Purpose</u>. The purpose of this act is to provide supplemental budget for
- 2 the Kosrae State operational budget and further contribute funding for the MLSC and
- 3 PIDB.
- Section 2. Apportionment. The sum appropriated in this act shall be apportioned
- 5 as follows:
- 6 1. FY2019 and FY2020 Personnel Budget \$70,000
- 7 2. MLSC \$10,000
- 8 3. PIDB \$30,000
- 9 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be
- 10 allotted, managed, administered and accounted for in accordance with applicable laws.
- 11 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
- shall be responsible for ensuring that these funds, or so much thereof as may be necessary,
- are used for the purpose for which are appropriated and that no obligations are incurred in

1	excess of the sum appropriated. The authority of the allottee to obligate funds
2	appropriated by this act shall lapse on September 30, 2020.
3	Section 4. Effective Date. This act takes effect upon the approval of the
4	Governor or upon its becoming law without such approval.
