Dear Mr. Speaker:

With much reservation, I signed L.B. 12-45 into LAW as State Law 12-30 of which the Title States;

"To appropriate the sum of \$3,000.00 from the local revenue fund of the Kosrae State treasury for the purpose of providing fund assistance for the 2019 municipal memorial celebrations for Tafunsak, August 6th, Malem, June 6th, and Utwe, July 20th; and for other purposes."

Mr. Speaker, I need to let you and the distinguished members of the 12th Kosrae Legislature know that although I appreciate the desire of the Legislature to assist the three municipalities' celebration activities to better serve our people, my real intention to this Bill was to veto it, based on the fact that we have come to a crossroad which dictates cash shortage comes fiscal year 2020.

However, based on personal consultation with the four Mayors of Tafunsak, Lelu, Malem, and Utwe Municipal Governments, and the strong commitments on all their parts to

discontinue requesting of State Revenue Funds to fund future memorial activities at the municipal level effective in 2020, I find it reasonable to allow this appropriation to go through.

### A BILL FOR AN ACT

To appropriate the sum of \$3,000 from the Revenue Fund of the Kosrae State Treasury for the purpose of providing fund assistance for the 2019 Municipal memorial celebrations for Tafunsak, August 6<sup>th</sup>, Malem, June 6<sup>th</sup>, and Utwe, July 20<sup>th</sup>; and for other purposes.

### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. <u>Appropriation</u>. The sum of \$3,000 is hereby appropriated from the
  Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the 2019
  Liberation Celebration for the Municipal Governments of Tafunsak, Malem and Utwe.

  Section 2. <u>Apportionment</u>. The sum amount in this act shall be apportioned as
- 1. Tafunsak Municipal Government \$1,000;

  2. Malem Municipal Government \$1,000;

  3. Utwe Municipal Government \$1,000.
  - Section 3. Allottee. All funds appropriated by this act shall be allotted, managed, administered, and accounted for in accordance with applicable laws. The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated and that no obligations are incurred in excess of the sum appropriated.
