#### A BILL FOR AN ACT

To further amend State Law 11-171, as amended by State Law 12-04, by amending funding appropriated under Sections 1, 2(1), 2(17), 2(18), 2(19), 2(20), 3, 4, 5, 6, 7, 8, 9, 10(2), 11, 12(3) and insert subsections 12(13) and 12(14) to include funding for the Micronesian Island Forum (MIF) and the Pacific Island Development Bank (PIDB; and for other purposes.

## BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. <u>Purpose</u>. The purpose of this act is to appropriate funding for the operations of the 3<sup>rd</sup> and 4<sup>th</sup> Quarters of the locally funded branches of the Kosrae State Government its agencies and various programs for the fiscal year ending September 30, 2019.
- Section 2. <u>Amendment</u>. State Law 11-171, as amended by State Law 12-04, is hereby further amended at Sections 1, 2(1), 2(17), 2(18), 2(19), 2(20), 3, 4, 5, 6, 7, 8, 9, 10(2), 11, 12(3) and insert subsections 12(13) and 12(14) to include funding for the Micronesian Island Forum (MIF) and the Pacific Island Development Bank (PIDB), as follows:

  so much thereof as may be necessary, is appropriated from the State Revenue Fund; the sum of
  \$960,374, or so much thereof as may be necessary, is appropriated from the United States Grant Fund;
  and the sum of \$382,246, or so much thereof as may be necessary, is appropriated from the Foreign
  Assistance Fund for the operation of the Executive Branch for the fiscal year ending September 30,2019.
- Section 2. Apportionment. Operation of the Executive. The sums appropriated by Section 1 of this act are apportioned as follows:
