

A BILL FOR AN ACT

To further amend Section 9.2102 at Title 9 of the Kosrae State Code by increasing the airport utilization fee from \$15 to \$20; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to amend Section 9.2102 of the
2 Kosrae State Code by increasing the airport utilization fee from \$15 to \$20 and provided
3 that the \$5 variation will be deposited into the Kosrae State Treasury.

4 Section 2. Amendment. Section 9.2102 of Title 9 of the Kosrae State Code is
5 hereby amended to read as follows:

6 Section 9.2102. Airport Utilization Fee. Each passenger departing from the Kosrae
7 International Airport to any destination outside Kosrae State pays an Airport Utilization
8 Fee of \$20.00. The fee is paid by or on behalf of each passenger and is collected by the
9 Director upon the passenger's departure from the State at the Kosrae International Airport
10 Terminal. The passenger does not have the right to depart from Kosrae International
11 Airport until the Airport Utilization Fee is received by the Director. The Director may
12 provide by regulation, procedures for the efficient collection and handling of Airport
13 Utilization Fee moneys, including the imposition of fines not to exceed \$50.00 for the
14 failure or refusal of any passenger to pay the Airport Utilization Fee. Provided that \$5.00
15 from every paid Airport Utilization Fee shall be deposited into the Kosrae State Treasury.
16 Payment to the Kosrae State Treasury from amount collected and received shall be made
17 on a quarterly basis from effective date or until prescribed otherwise by law. Provided



1 further, a quarterly report to the Governor and the Legislature on the collection made by
2 the Director of Administration and Finance, and to appear, in person, before the
3 Legislature when necessary. The Director of Administration and Finance shall establish a
4 separate account within the Kosrae State Treasury for the amount received and collected.”

5 Section 4. Effective Date. This act takes effect upon the approval of the Governor
6 or upon its becoming law without such approval.
