A BILL FOR AN ACT

To amend the Kosrae State Code by repealing Section 4.304 (1),(2),(3),(4),(5) of Title 4, Section 5.508 (1), (2),(3),(4),(5) of Title 5, and Section 6.1206 (1),(2),(3),(4),(5) of Title 6 of the Kosrae State code; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to amend the Kosrae State Code by  
2 repealing Section 4.304 (1),(2),(3),(4) and (5) of Title 4, Section 5.508 (1), (2),(3),(4) and  
3 (5) of Title 5, and Section 6.1206 (1),(2),(3),(4) and (5) of Title 6 of the Kosrae State  
4 Code.

5           Section 2. Amendment. Title 4, Chapter 3, Section 4.304 (1),(2),(3),(4) and (5) of  
6 the Kosrae State Code is hereby repealed:

7           Section 4.304. Representation funds.

8 Purpose of fund is to support and facilitate the efficient and effective discharge of duties  
9 and responsibilities of Senators. Expenditures are at the discretion of Senators.  
10 Disbursement of compensation will be based on signed written approval by the Speaker of  
11 the Legislature.

12           Section 3. Amendment. Title 5, Chapter 5, Section 5.508 (1),(2),(3),(4) and (5) of  
13 the Kosrae State Code is hereby repealed:

14           Section 5.508. Representation funds.

11 Section 5. Effective Date. This act takes effect upon the approval of the Governor  
12 or upon its becoming law without such approval.
