A BILL FOR AN ACT

To amend Section 11.609 at Title 11, Chapter 4 of the Kosrae State Code, by increasing the annual compensations of the Land Court Justices; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to amend Section 11.609 of Title 11 of the
2 Kosrae State Code by increasing the annual compensations of the Land Court Justices.

3 Section 2. Amendment. Section 11.609 of Title 11, Chapter 4 of the Kosrae State Code is
4 hereby amended to read as follows:

5 “Section 11.609. Compensation. The Principal Land Justice shall receive an
6 annual compensation in the amount of seventeen thousand one hundred (\$17,100) dollars.
7 The Associate Land Justices shall receive an annual compensation in the amount of
8 fifteen thousand two hundred dollars. The amount of compensation shall not be
9 increased or decreased during their terms of office, except by general law applying to all
10 State Government employees.”

11 Section 3. Effective Date. This act shall become law upon approval by the Governor or
12 upon its becoming law without such approval.
